CALL TO ORDER:

Mayor Karl Curtis called the meeting to order at 7:00pm.

NEW BUSINESS:

a. 2019 Audited Financial Statements

A review of the Town's 2019 Audited Financial Statements provided by Oulton Parkinson Walker Derrah showed that the General Operating Fund had a surplus for 2019 of \$11,397 and the Utility Operating Fund showed a surplus for 2019 of \$2,047.

MOTION: To adopt the 2019 Audited Financial Statements as presented. Moved by Councillor Elizabeth Campbell, seconded by Councillor Dan Guest.

b. Appointment of Auditor for 2020

MOTION: To appoint Oulton Parkinson Walker Derrah as the 2020 Town auditors. Moved by Deputy Mayor Nancy Whyte-McCauley, seconded by Councillor Dan Guest.

c. School Street Speed Bumps

Council reviewed a report from WSP, which outlined advantages and disadvantages of installing speed bumps on School Street. At this time, WSP does not recommend installing new speed bumps as they believe they have little impact if any.

MOTION: Not to proceed with the installation of speed bumps on School Street. Moved by Councillor Dan McCarthy, seconded by Councillor Dan Guest.

OLD BUSINESS:

a. Hume Road Sewer Main Extension Request

Council reviewed an estimated cost from engineers, WSP, to extend the Town sewer to Hume Road. They estimate the project will cost \$1,300,000 plus HST, plus engineering fees. There are approximately 12 homes plus an apartment building on Hume Road. This translates into a cost of \$100,000 per building that would be hooked up.

MOTION: Not to proceed with the sewer extension to Hume Road due to the significant cost per household. Moved by Councillor David Trafford, seconded by Councillor Dan Guest.

b. Proposed Art Gallery Sign

The Andrew and Laura McCain Art Gallery (ALMAG) had previously asked Council for permission to have two permanent anodized aluminum signs made to replace two of the banner spots on nearby lamp posts. Council had agreed, but wanted to approve the final design. Council reviewed two designs proposed by ALMAG.

MOTION: To approve both designs as presented by ALMAG for insertion onto the two previously approved lamp posts. Moved by Deputy Mayor Nancy Whyte-McCauley, seconded by Councillor Dan McCarthy.

c. 2024 Solar Eclipse Speaker

David Hunter presented at the last Council meeting an idea for an event to celebrate the 2024 Solar Eclipse that will be directly passing over our Town. He proposed a speaker with the caliber of Chris Hadfield would draw a big crowd to the event, helping to offset the higher cost. He suggested other speakers at a lower cost, but noted they would not bring the people that Mr. Hadfield would.

MOTION: To secure Chris Hadfield as a speaker for the 2024 Solar Eclipse event by paying the deposit of \$25,000 plus HST. Moved by Deputy Mayor Nancy Whyte-McCauley, seconded by Councillor David Trafford.
