

# Q1 Which of the following best describes the impact of COVID-19 on your non-profit right now?





# Q2 If you have stopped operating or providing services or programs at this time, what is your financial forecast?





### Q3 Have you experienced disruption of services to clients and communities







# Q5 What measures are you likely to use/need to address the economic impact of the COVID-19 pandemic?







# Q7 Beyond what has already been announced, what do you need from the provincial and federal governments?





# Q8 What do you need from your local municipal governments right now? (ranked by greatest need)






#### Q10 How does your number of employees/volunteers prior to COVID-19 compare to today?



#### Q11 How many employees/volunteers do you have today?




