CALL TO ORDER:

Mayor Karl Curtis called the meeting to order at 7:01pm.

APPROVAL OF AGENDA:

MOTION: To approve the November 15, 2022 Town Council Agenda. Moved by Deputy Mayor Nancy Whyte-McCauley, seconded by Councillor Dan Guest.

CARRIED. #126-2022

PRESENTATIONS:

a. Fire Chief Update

The department attended 3 motor vehicle accidents since the last Regular Council Meeting. They had problems with their trunked mobile radio system, but it has been resolved. The department continued its bi-weekly training and did a training exercise at McCain Foods simulating a propane fire.

b. Knowlesville Art and Nature Centre (KANC)

KANC Executive Director Tegan Wong-Daugherty and Project Coordinator Rae Sharp explained that they would like to work together with the Town to create an Acadian Forest nursery, for tree and plants that are native to our area of New Brunswick. They are seeking places within our town to have tree planting activities, accessible to the general public and places for people to learn about the role trees play for the health of our land and our own health. The KANC will work with staff to determine an appropriate location for some planting beds.

c. Policing and Crime Concerns, Zak Hargrove

Zak Hargrove asked Council to pass a motion to ask the Minister of Justice and Public Safety to provide additional resources for the new District of Carleton North in the form of a local detachment. The Director of Policing Standards & contract Management with the provincial department of Public Safety advised the process to request additional policing or a detachment would be:

- The RCMP provides a regional policing model so a decision would have to be made by a
 governing body representing all citizens who pay for the police service. This could be at
 the RSC level where municipal and LSD representatives meet.
- Once a formal decision is made by the governing body a letter outlining your request along
 with supporting rationale can be provided to the Minister of Public Safety. A copy of the
 letter should also be submitted to the RCMP so that they are aware of your request.
- Once the Minister receives the letter, stakeholder engagement will start in an effort to get the information required to determine the next steps based on the request.

 Any request for a local detachment would be included in the letter to the Minister and the RCMP.

MOTION: To recommend the District of Carleton North Council work with the Regional Service Commission to investigate further into the feasibility of additional police services, including a local detachment as a high priority item. Moved by Councillor David Trafford, seconded by Councillor Ryan Dickinson.

d. Public Hearing - 6 Welch Street

Council of the Town of Florenceville-Bristol has been asked to amend the Municipal Plan By-Law #12A and the Zoning By-Law #13B by rezoning the following property:

PROPERTY: PID 10237113, 6 Welch Street

REZONING: from "C-1" Neighbourhood Commercial Zone to "C-2" General Commercial Zone **PURPOSE:** In addition to the permitted yoga and spa uses of the C-1 Zone, the property owner would like to add a café-style restaurant including a beverage room, which would offer on-tap flights (tasting samples) in a relaxing atmosphere to learn about local and Canada-wide brew and wine.

There were no written submissions received for or against the proposed rezoning request.

A letter was read from Assistant Development Officer Nick Redden, advising he did not have any concerns about the proposed rezoning. He noted there is an existing 7.62m right-of-way registered on the property, which will allow ongoing access to the cemetery behind the church.

A letter from the P.A.C. was read that recommended Council proceed with the proposed rezoning of PID 10237113 from C-1 Neighbourhood Commercial Zone to C-2 General Commercial Zone with no terms or conditions.

Council will consider 1st and 2nd readings under New Business.

e. Public Hearing – 17 Old Schoolhouse Lane

Council of the Town of Florenceville-Bristol has been asked to amend the Municipal Plan By-Law #12A and the Zoning By-Law #13B by rezoning the following property:

PROPERTY: PID 10083772, 17 Old Schoolhouse Lane (off Riverview Drive) **REZONING:** from "INST" Institutional Zone to "MU-1" Mixed Use Main Street Zone **PURPOSE:** The church would like to operate a daycare centre in the existing building

Seven written submissions were read, all in favour of the daycare centre. Many expressed a lack of daycare spaces were available in the area due to the closure of the 49 McCain Street daycare. With people working from home during the Covid shutdown, some are unable to return to working outside the home because of a lack of daycare.

A letter was read from Assistant Development Officer Nick Redden, advising he did not have any concerns about the proposed rezoning.

A letter from the P.A.C. was read that recommended Council proceed with the proposed rezoning of PID 10083772 from "INST" Institutional Zone to "MU-1" Mixed Use Main Street Zone with no terms or conditions.

Council will consider 1st and 2nd readings under New Business.

f. Public Hearing – 49 McCain Street

Council of the Town of Florenceville-Bristol has been asked to amend the Municipal Plan By-Law #12A and the Zoning By-Law #13B by rezoning the following property:

PROPERTY: PID 10084580, 49 McCain Street

REZONING: from "MU-2" Mixed Use Core Zone to "MU-1" Mixed Use Main Street Zone

PURPOSE: The property owner would like to operate a daycare centre in the existing building,

and due to a zoning map change, it is no longer a permitted use in the MU-2 zone.

No submissions for or against the proposed rezoning were received, but it was noted several of the comments received for the Old Schoolhouse Lane rezoning applied for this request as well.

A letter was read from Assistant Development Officer Nick Redden, advising he did not have any concerns about the proposed rezoning.

A letter from the P.A.C. was read that recommended Council proceed with the proposed rezoning of PID 10084580 from "MU-2" Mixed Use Core Zone to "MU-1" Mixed Use Main Street Zone with no terms or conditions.

BUSINESS ARISING FROM MINUTES:

a. Municipal Reform

- The CAO has continued meetings with the Transition Facilitator regarding the CAO position, the budget process, the budget details, administrative matters, and human resource matters.
- The Transition Facilitator made the decision that Carleton North will be going with the WVRSC for its planning and building inspection services because other than Florenceville-Bristol, the rest of the area used them in the past and Florenceville-Bristol is only 16% of the population and 33% of the tax base.
- The Province is not going to be reimbursing any expenses for Carleton North. The draft budget was increased accordingly to cover these expenses.
- The final budget recommendation was sent to the Transition Facilitator this week.
- The CAO continued talks with the HR Consultant to determine the new organizational structure.

b. Regional Service Commission (RSC) Reform

- The Mayor and CAO met with both the municipal and RSC Transition Facilitators and the RSC CEO to discuss the cost of the planning for Carleton North.
- The planning cost will be approximately \$87,000 more for the RSC to provide than the Town's contractors, but the Transition Facilitator feels the RSC is the best provider since the majority of the District of Carleton North is already using the RSC for planning.
- Barb Sharp was appointed to the new position of Director of Tourism for the RSC.

CORRESPONDENCE:

a. Dog Report

The September and October Dog Reports were reviewed. There were no new calls for animal control service in September or October. A warning was issued in October to have a resident renew their dog tags, and they complied.

b. Noise Concerns

A letter was read from Dr. Clay Marco, outlining his concerns for enjoyment of the one's property as well as being able to enjoy frequenting local businesses due to excessive noise from ATVs and dirt bikes on Town streets. He wanted the Town to adopt and enforce a Noise By-law that would eliminate the excessive noise created by the illegal use of these motorized vehicles.

c. Family Violence Awareness Month

A letter was read from Manon Albert, Chair of the River Valley Caring Communities Committee, asking the Town to string purple lights up on a building to symbolize that domestic violence has no place in our community. Staff suggested the Library window or a lamp post could be suitable options. Christmas lights will be lit following the Nov 24 Tree Lighting event.

MOTION: To display a string of purple lights on a location determined by staff until the Christmas light season starts. Moved by Councillor Andy Saunders, seconded by Deputy Mayor Nancy Whyte-McCauley.

NEW BUSINESS:

a. ACOA Rediscover Main Street Grant

As part of agreement with ACOA's Rediscover Main Street initiative, which included the Tunesday in the Park summer music event, the Town's financial contribution to the project was to invest a minimum of \$27,663 to Christmas decorations. The decorations would include 25 LED lamppost lights, a tree topper for the potato barrel Christmas tree and 6 custom tree stands. The funds would come out of the tourism operating budget.
