Jennifer Stead updated Council on what has been going on at the ALMAG and explained their mandate is to foster creativity through art and art expression. She said they have been working to increase their efficiency and enrich the community through art. She noted they are only not for profit art gallery between Fredericton and Edmundston. Their next show is by nationally renowned artist Thaddeus Holownia opening on April 28th from 2-4pm.

Stephen Hutchings outlined that their objective is to make a link between the ALMAG and tourism. The Sponsorship Committee is reaching out to the community to see how they would like to partner including ideas such as public art, workshop programs, etc.
